I – SPECIFIC CONDITIONS

SIMPLIFIED PROCEDURE FOR DIRECT PROCUREMENT

<u>1 – PURPOSE OF THE PROCUREMENT</u>

The purpose of this Procurement is to provide *seven desktop computers to the Argentine Embassy in full according to this terms and conditions* to the Representation of Argentina in UAE. The hiring Government Office will be the Embassy of Argentina to the United Arab Emirates, located in Abu Dhabi City, fully in accordance with these Specific Conditions, the Technical Specifications and the other documents governing the procurement.

2 - HOW TO SUBMIT BIDS

Bids may be submitted:

a) In person and inside a sealed envelope, at Embassy of the Argentine Republic at United Arab Emirates, located in Al Rowdha area, Street 11, villa 18, PO Box 3325, Abu Dhabi, United Arab Emirates. On business days, from Sunday through Thursday, from 8.30 am to 4.00 pm until September 22nd, 2016 at 11.00 am.

Submission of a bid implies full knowledge and acceptance by the bidder of the provisions governing this Procurement and the interpretation of its precise scope.

Bids may only be submitted until the submission deadline established. No changes introduced thereafter will be accepted.

<u>3 – CONTENT OF THE BID</u>

The bid must be drafted in English. All deletions, amendments, erasures and text added between lines must be duly initialled by the persons signing the bid.

The bid must be signed on each and every page by the bidder or their legal representative.

The bid must include the following information:

3.1) Name and surname, address, telephone number, fax number and e-mail address.

3.2) Special domicile established in (city/locality of the Representation).

3.3) Description of the BID: The goods or services tendered must be described. To this end, leaflets, manuals and other materials may be included.

Make, model and other relevant information relating to the goods tendered must be included where applicable, including information on whether said goods are new or unused.

3.5) Quote form completed and signed in accordance with Section 4 hereof.

<u>4 – QUOTING METHOD</u>

Quotes must respect the quantities and units of measurement stated in the Quote form, which should include both the unit price and total price. The Quote form must be signed by the bidder or their legal representative.

The total price stated in the quote will be the final price paid by the Representation for all costs and expenses, including taxes and shipping costs, if any.

In the event that the total amount quoted for each line does not match the unit price, the latter will be taken as the quoted price. Errors in any other quoted amounts that are informed by the bidder or detected by the procuring entity before the award will result in the dismissal of the relevant portions of the bid.

<u>5 – VALIDITY OF THE BID</u>

The bid shall be valid for a term of THIRTY (30) running days as from the date fixed for the opening of bids.

<u>6 – OPENING OF BIDS</u>

At the date and time established, bids will be opened in a public meeting, in the presence of the officers appointed to that end and of any persons wishing to attend the meeting. The relevant record will be drafted and signed by all acting officers, as well as by any bidders or interested parties present and wishing to do so.

7 – REVIEW OF BIDS

During the bid review period, bidders may be requested to rectify any amendable errors or omissions in their bids. Bidders may not amend errors or omissions in any way that alters the substance of their bid or improves it in order to gain advantage over other bidders.

If a bidder fails to act upon the rectification request within the term established, their bid will be deemed abandoned.

8 – NON-AMENDABLE GROUNDS FOR BID DISMISSAL

Bids will be dismissed with no opportunity for rectification in the following cases:

- a) Bids drafted in a language other than that established in the bidding terms and conditions.
- b) Bids that are not signed by the bidder or their legal representative in any of the pages.
- c) Bids containing erasures, deletions, amendments or text added between lines that are not initialled in the financial proposal, the description of the goods or services offered, the term of delivery, or any other section that is of the essence to the contract.
- d) Bids that have a shorter term of validity than that established in the bidding terms and conditions.
- e) Bids drafted in pencil or any other means that can be erased and rewritten without trace.
- f) Bids submitted by persons who are currently suspended or prohibited from seeking contracts with the Argentine Government at the time of the opening of the bids, during the bid review period, or at the time of the award.
- g) Bids submitted by individuals or legal entities that are not authorized to seek contracts with the Argentine Government at the time of the opening of the bids, during the bid review period, or at the time of the award.
- h) Bids containing any qualifications.
- i) Bids containing terms that infringe the rules governing the procurement or that prevent a precise comparison against the rest of the bids.
- j) Bids containing substantial errors or omissions.
- k) Bids with quoted prices that are excessively low or not serious.
- 1) Bidders who are ineligible.
- m) Bidders submitting more than one bid, either on their own or as part of a group, association or legal entity. This prohibition shall not apply where bids submitted include discounts, alternatives or different options.
- n) Samples not included within the term established in the bidding terms and conditions, where applicable.

<u>9 – AWARD</u>

The contract will be awarded to the bid that complies with all the requirements hereof and offers the lowest price.

The successful bidder and the rest of the bidders will be notified of the award no later than THREE (3) business days following the award, by any of the following means:

- a) direct access to the relevant file by the bidder or their legal representative;
- b) appearance of the interested party or their legal representative at the relevant office, which indicates that the result has come to their knowledge;
- c) certified return receipt letter, or any other postal means that certifies sufficient notice;
- d) fax; or
- e) e-mail.

No later than TEN (10) business days after notice of the award is given, the relevant purchase order will be issued, and the successful bidder will be notified by the same means.

<u>10 – TIME AND PLACE OF DELIVERY</u>

The delivery of the *seven desktop computers to the Argentine Embassy in full according to this terms and conditions* shall be made within 5 (five) business days as from the day following the receipt of the Purchase Order, to the Embassy of the Argentine Republic at United Arab Emirates, located in Al Rowdha area, Street 11, villa 18, PO Box 3325, Abu Dhabi, United Arab Emirates. On business days, from Sunday through Thursday, from 8.30 am to 4.00.

<u>11 – ACKNOWLEDGEMENT OF RECEIPT</u>

Shipping lists shall be sent to Al Rowdha area, Street 11, villa 18, PO Box 3325, Abu Dhabi, United Arab Emirates.

The header of all shipping lists must include the Purchase Order Number.

The Representation shall have the right to perform all the checks and technical tests it may deem necessary.

If any of the batches delivered is rejected, for the purposes of the penalties set forth in Section 14 hereof, the date of delivery shall be the date on which delivery of the new replacement batch is accepted, provided it complies with the relevant requirements.

12 – TERMS OF PAYMENT AND SUBMISSION OF INVOICES

Invoices will be paid fifteen days (15) working days after submission.

Invoices may be submitted after acceptance of delivery, to Embassy of the Argentine Republic at United Arab Emirates, located in Al Rowdha area, Street 11, villa 18, PO Box 3325, Abu Dhabi, United Arab Emirates.

<u>13 – GUARANTEE OF GOODS</u>

All items provided must have one year of full warranty for any failure. Of any component has to be change, the supplier will have to straight out all the cost.

14 – TERMINATION OF THE CONTRACT

Where the successful bidder expressly abandons the contract before the term established for its fulfilment, or where the goods remain undelivered after the expiry of said term, the procuring entity will declare the contract terminated without any court or out-ofcourt procedures, unless it decides to accept late fulfilment.

<u>15 – LIABILITY</u>

The co-contractor shall comply with all laws applicable to the activities conducted under the contract and shall be liable for all court and out-of-court claims, including all costs and expenses resulting from any actions or omissions of the co-contractor, its staff or subcontractors, or any other persons who may be liable to the co-contractor for compliance with any of these terms and conditions.
