# **VISA REQUIREMENTS**

- 1. 1 (One) copy of the application form duly completed (digital or manually). Applicants are required to sign the form in front of a Consular Officer.
- 2. 1 (One) recent photograph with white background, size 4cm x 4cm.
- 3. 1 (One) copy of the passport and all the visas stamped.
- 4. Letter of employment (Company letterhead, stating the position, seniority, monthly remuneration and contact person).
- 5. Airline ticket. (It is advisable not to purchase the tickets until the visa has been granted)
- 6. Hotel Reservation (guaranteed by credit card) and must show the applicant's name for the duration of the stay in Argentina or statement from a travel agency showing tourist program, etc.
- 7. Travel insurance (Worldwide).
- 8. Original passport and UAE residence visa valid for at least 6 months from the date the application is submitted. In case your visa is about to expire, we require a letter from your employer, declaring that they have no objection to renew the visa upon your return.

Note: Please glue the photo onto the visa application form in the designated space and please DO NOT STAPLE any document.

## **ADDITIONAL TO VISA REQUIREMENTS**

#### a) For tourism propose:

- Three last credit card receipts, last credit card summary and / or last bank account summary.
- In case of not having hotel reservation, an invitation letter in Spanish, attested by Public Notary (Please ask the person in charge of the visa section for the requirements and a model).

#### b) For business propose:

• Original Invitation Letter in Spanish, with RENURE number and attested by Public Notary (Please ask the person in charge of the visa section for the requirements and a model).

### c) For professional propose:

• Original Invitation Letter in Spanish.

### **OTHER INFORMATION:**

- Visa validity will be for 90 days.
- Other documents may be requested as deemed necessary by Consular Staff.
- The Embassy will not be responsible for any mistakes in the visas which were not brought to its attention by the passport holder prior to departure to Argentina.
- Should an emergency related with your visa arise after issuance, you can contact the following cell phones: +971 50 6113274.
- Application Submission: Please note that an appointment is necessary to come and submit the application.
   Please write us an e-mail to: consular\_eearb@mrecic.gov.ar once you have all the documents required for the application.
- The applicant must come **PERSONALLY** and be on time, failure to come in person and on time the appointment will be cancelled and a new one will need to be schedule.
